

# *DIRECTIONS TO FOWLERHOFFMAN*

---

(from the Richmond-San Rafael Bridge, Berkeley, Oakland Airport, Sacramento, San Francisco, San Francisco Airport & Sonoma County.)

## From the Richmond-San Rafael Bridge

- From Interstate 580 cross the Richmond-San Rafael Bridge.
- Take the first Marin County exit: East Francisco Blvd/San Quentin Exit.
- Continue straight on East Francisco Blvd. We are located at 1925 East Francisco Blvd., Suite G, just past Mayflower Moving Company. Parking is available in the front lot near our entrance.

## From Berkeley

- Take the Interstate 80 E/ Interstate 580 W ramp.
- Merge onto I-80 East/I-580 West
- Continue on 580 West towards Point Richmond/San Rafael.
- Cross the Richmond-San Rafael Bridge. Stay in the right lane.
- Take the first Marin County exit: Francisco Blvd. East/San Quentin Exit. The exit is immediately where the bridge guard rail ends.
- Continue straight on Francisco Blvd. East. We are located at 1925 East Francisco Blvd., Suite G, just past Mayflower Moving Company. Parking is available in the front lot near our entrance.

## From Oakland Airport

- Turn left onto Airport Drive.
- Turn right onto Hegenberger Road.
- Take the Interstate 880 North ramp towards downtown Oakland.
- Merge onto Interstate 880 North.
- Take Interstate 80 East.
- Take Interstate 580 West towards Point Richmond/San Rafael.
- Cross the Richmond-San Rafael Bridge.

- Take the first Marin County exit: East Francisco Blvd/San Quentin Exit.
- Continue straight on East Francisco Blvd. We are located at 1925 East Francisco Blvd., Suite G, just past Mayflower Moving Company. Parking is available in the front lot near our entrance.

## From Sacramento

- Take I-80 to I-80 West
- From 80 take the Richmond Parkway/Fitzgerald (I-580) exit.
- Turn right onto Richmond Parkway, follow for a few miles.
- Veer right onto Castro Street, follow straight and turn left on the I-580 ramp.
- Merging on to I-580 West, cross the Richmond-San Rafael Bridge.
- Take the first Marin County exit: East Francisco Blvd/San Quentin Exit.
- Continue straight on East Francisco Blvd. We are located at 1925 East Francisco Blvd., Suite G, just past Mayflower Moving Company. Parking is available in the front lot near our entrance.

## From San Francisco

- Travel north on Hwy 101 and cross the Golden Gate Bridge.
- Continue North on Hwy 101 past the Paradise Drive Exit in Corte Madera. The Village Shopping Center is on the right with Macy's and Nordstrom. You'll want to eventually be in the far right lane. Take the exit past Lucky Drive Exit with signs for San Anselmo and US-101 North/Richmond Bridge. You want to go east (right) toward the Richmond Bridge.
- As you take this exit and bear right onto East Sir Francis Drake Blvd.
- Continue on East Sir Francis Drake Blvd. past Larkspur Landing and San Quentin.
- Continue over the hill and remain in the right lane...do not merge onto the freeway. This lane becomes the Last Marin County Exit and it will take you to an intersection at the base of the overpass. Take a left here and go under the freeway.
- Turn left onto Francisco Blvd. East.
- We are located at 1925 Francisco Blvd. East, Suite G, just past Mayflower Moving Company. Parking is available in the front lot near our entrance.

## From San Francisco Airport

- Leaving the airport, stay in the right lane. Take highway 380 heading west.
- Merge onto highway 280. Take the 19<sup>th</sup> Avenue Exit.
- Continue on 19<sup>th</sup> Avenue, and cross the Golden Gate Bridge.
- Continue traveling North on Hwy 101
- Travel north on Hwy 101 and cross the Golden Gate Bridge.
- Continue North on Hwy 101 past Paradise Drive Exit. You'll want to eventually be in the far right lane.
- You'll approach a major intersection of freeway exits/entrances with exit signs for San Anselmo and US-101 North/Richmond Bridge. You want to go east (right) toward the Richmond Bridge.
- Take this exit and bear right onto East Sir Francis Drake Blvd.
- Continue on East Sir Francis Drake Blvd. past Larkspur Landing and San Quentin.
- Continue over the hill and remain in the right lane...do not merge onto the freeway. This lane is the last Marin County exit and it will take you to an intersection at the base of the overpass. Take a left here and go under the freeway.
- Turn left onto East Francisco Blvd.
- We are located at 1925 East Francisco Blvd., Suite G, just past Mayflower Moving Company. Parking is available in the front lot near our entrance.

## From Sonoma County

- Take Highway 101 South.
- From 101 take the Richmond Bridge/Oakland (I-580 East) exit.
- Take the last Marin County exit: East Francisco Blvd/San Quentin Exit.
- Turn left under the overpass and turn left again onto East Francisco Blvd.
- Continue straight on East Francisco Blvd. We are located at 1925 East Francisco Blvd., Suite G, just past Mayflower Moving Company. Parking is available in the front lot near our entrance.
